<u>RESOLVED</u>:- to support the proposed diversion.

b) Wem Speed limit Alterations (Various location around Thomas Adams School) – to consider

<u>RESOLVED</u>:- that the Town Council supports the proposed speed limit alterations and parking restrictions around Thomas Adams School. However, the Council requests that the proposed 20mph zone be extended along Pyms Road towards the junction with New Street and then along New Street to link up with the existing 20mph zone at the junction of New Street and Park Road. New Street is heavily used by students from Thomas Adams and St Peters Schools and reducing the speed limit along this road would significantly improve road safety for pedestrians.

The Town Council would also request that the missing 20mph signage in New Street at the junction with Park Road is reinstalled as this was removed following a collision some years ago.
